

直感的なデザインで色の変更や希望の設定を探す際により使いやすくなっている。さらに、コントロールパネルは取り外しができコネクターケーブルを使うと手持ちで使用することができる。

コントロールパネルの使用

オプションの Orbiter 用コントロールパネルは直接照明器具につなげる、あるいは Orbiter からケーブルリモートをつなげて使用できる。Orbiter に調節取り付ける場合、照明器具の後ろ側(下の図を参照)にある凹みに磁石で固定ができる。凹みにコントロールパネルを挿入すると、自動的に Orbiter につながるようになっている。

コントロールパネルの挿入と取り外し

コントロールパネルは照明器具の電源が入っている時に接続と取り外しが可能。照明器具で最後に使用した設定がコントロールパネルに保存される。

コントロールパネルの取り外し:

- ・コントロールパネルを少し左に押す。
- ・コントロールパネルを右に持ち上げる。
- ・コントロールパネルを右に持ち上げて凹みから取り出す。

コントロールパネルの接続:

- ・コントロールパネルを左斜めに凹みに押し入れる。
- ・カチッと音がするまでコントロールパネルの右側を凹みの中に押し入れて固定をする。コントロールパネルは磁石で凹みに固定される。照明器具の電源を入れると、少し時間が経てばコントロールパネルも起動する。

コントロールパネルケーブルの接続と取り外し

コネクターケーブルの 4-pin レモコネクターを照明器具のコネクターとコントロールパネルに差し込む。コネクターは自動的にロックする。コネクターを無理に差し込まない。コネクターの赤い点とデバイスコネクターの赤い点が平行になるように並べる。デバイスコネクターに対して、ラインコネクターの正しい位置を確認できる。レモコネクターのリングを後ろに引っ張り、コネクターを引き出す。

NOTICE

コントロールパネルは Orbiter につなげて直接使用する、あるいは Orbiter からケーブルリモートとつなげて使用できる。二つのコントローラーを使用している場合、コネクトケーブルでつないでいる方のコントロールが優先される。
